# 2020 BLUE JAYS<sup>™</sup> FAN FRENZY CONTEST (the "Contest") OFFICIAL RULES

# NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The sponsor of this Contest is Rogers Blue Jays Baseball Partnership, located at One Blue Jays Way, Suite 3200, Toronto, Ontario M5V 1J1 ("Sponsor"), owner of the *Toronto Blue Jays*<sup>TM</sup> Major League Baseball team (the "Team"). The Toronto-Dominion Bank, located at 77 King Street West, TD Tower North, 9<sup>th</sup> Floor, Toronto, ON M5K 1A2 ("TD") is a supporting presenter of the Contest but is not a Contest sponsor. For inquiries relating to the Contest, please contact the Sponsor.

#### 2. ELIGIBILITY:

- (a) The Contest is open only to residents of Canada, excluding the Province of Quebec who are of age of legal majority in the province/territory in which they reside at the time of entry.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) the other MLB Entities (defined below), (iii) TD, (iv) each of their respective parents, affiliated companies, and subsidiaries, and (v) any and all other companies associated with the Contest. The "MLB Entities" shall mean the Office of the Commissioner of Baseball (the "BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. ("MLBAM"), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the "Clubs"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof to the complete satisfaction of Sponsor may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

- (a) The Contest entry period begins at 12:00 p.m. Eastern Time ("ET") on Tuesday, September 22, 2020 and ends at 12:00 p.m. ET on Friday, September 25, 2020 (the "Entry Period").
- (b) <u>Limit of one (1) Entry (defined below) per person/email address.</u> By way of illustration, if two (2) or more otherwise eligible persons share a single email address, only one (1) of them may enter the Contest. If one (1) person has two (2) or more email accounts that person may enter the Contest only once and only the first entry received from such person will be considered.
- (c) There is only one (1) way to enter the Contest: online via bluejays.com. No other method of entry will be accepted. To enter the Contest, go to <u>www.bluejays.com/fanfrenzycontest</u> during the Entry Period, complete the online entry form as instructed, including a valid email address and all other required information and submit the completed online entry form. By successfully transmitting a completed Entry (defined below) as directed, you will be entered in the Contest. Each entry that is fully completed, complies with the foregoing requirements and is submitted in accordance with the instructions set forth above is referred to as an "Entry". Incomplete entries will be deemed void.

- (d) MLBAM's computer shall be the official clock of the Contest with respect to Entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (e) By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM's Terms of Use accessible at: <u>mlb.com/tou</u> and Privacy Policy accessible at: <u>mlb.com/privacy</u>. Information submitted by entrants on bluejays.com will be provided to Sponsor and treated in accordance with Sponsor's Privacy Policy available at www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant's consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant's chances of winning.

#### 4. PRIZE DESCRIPTION:

Seventy-eight (78) prizes will be awarded. Winners will each win one (1) of the following prizes (the specific prize to be determined in the sole discretion of Sponsor):

(a) one (1) baseball autographed by one (1) Team player (the specific player to be determined by Sponsor in its sole discretion) (estimated retail value of CDN \$16);

# <u>OR</u>

(b) one (1) baseball bat autographed by one (1) Team player (the specific player to be determined by Sponsor in its sole discretion) (estimated retail value of CDN \$40);

#### <u>OR</u>

(c) one (1) "replica" Team-branded jersey autographed by one (1) Team player (the specific player to be determined by Sponsor in its sole discretion) (estimated retail value of CDN \$149.99);

# <u>OR</u>

(d) the opportunity for the winner to participate in a virtual "meet-and-greet" event with the Team's mascot, *Ace<sup>TM</sup>*, via a video conferencing platform (such video conferencing platform to be selected by Sponsor in its sole discretion) on a date to be determined by Sponsor in its sole discretion (estimated retail value of CDN\$250)

# <u>OR</u>

(e) the opportunity for the winner to participate in a virtual "meet-and-greet" event with one (1) Team player (such player to be selected by Sponsor in its sole discretion) via a video conferencing platform (such video conferencing platform to be selected by Sponsor in its sole discretion) on a date to be determined by Sponsor in its sole discretion (estimated retail value of CDN\$300);

#### <u>OR</u>

(f) one prize package consisting of: one (1) unbranded baseball, one (1) unbranded vial of dirt, and one (1) stadium seat cover (estimated retail value of CDN\$125);

#### <u>OR</u>

(g) one (1) "authentic" Team-branded alternate jersey and one (1) "authentic" Team-branded alternate cap (estimated retail value CDN\$400);

#### <u>OR</u>

(h) one (1) Jr. Jays-branded merchandise package (estimated retail value of CDN\$100).

The exact prize selected for each winner is at Sponsor's sole discretion. Any difference in value will not be awarded.

#### 5. PRIZE CONDITIONS:

- (a) Any and all Contest prizes must be accepted as awarded and may not be transferred, assigned, or redeemed for cash except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, any prize is provided "as is" without further warranty of any kind.
- (b) Some restrictions may apply. All prize details, including the exact nature, type and quality of any items to be awarded and the specific date, time, nature and duration of any experiences awarded will be determined in the sole discretion of Sponsor. Some restrictions may apply. Actual value of any autographed items is subject to market fluctuations. Autographed items and other memorabilia are not game used and no Certificate of Authenticity will be provided. In order to participate in any virtual experiences, the winners are solely responsible for securing access to a computer or mobile device with Internet connectivity and which is compatible with the video platform selected by Sponsor to be used for such virtual experiences.
