## THE BLUE JAYS ${ }^{\text {™ }}$ SOUVENIRS FROM TORONTO CONTEST (the "Contest")

(formerly the "Blue Jays Souvenirs from Buffalo Contest")

## OFFICIAL RULES - amended August 1, 2021

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR: The sponsor of this Contest is Rogers Blue Jays Baseball Partnership, owner of the Toronto Blue Jays ${ }^{\mathrm{TM}}$ Major League Baseball team (the "Team") with offices located at One Blue Jays Way, Toronto, ON M5V 1J1 ("Sponsor").

## 2. ELIGIBILITY:

(a) The Contest is open only to residents of Canada, excluding the Province of Quebec, who are of age of legal majority in the province/territory in which they reside at the time of entry.
(b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) the other MLB Entities (defined below), (iii) each of their respective parents, affiliated companies, and subsidiaries, and (iv) any and all other companies associated with the Contest. The "MLB Entities" shall mean the Office of the Commissioner of Baseball (the "BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. ("MLBAM"), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the "Clubs"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
(c) Sponsor shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

## 3. HOW TO ENTER:

(a) The Contest period (the "Contest Period") begins at 10:00 a.m. Eastern Time ("ET") on Tuesday, June 1, 2021 and ends at 11:59 p.m. ET on Thursday, September 30, 2021 and consists of four (4) entry periods (each, an "Entry Period"), all as further outlined in the following tables:

(b) Limit of one (1) Entry (as defined below) per person/email address, per Entry Period. By way of illustration, if two (2) or more otherwise eligible persons share a single email address, only one (1) of them may enter the Contest during any Entry Period. If one (1) person has two (2) or more email accounts, that person may enter the Contest only once during any Entry Period and only the first entry received from such person during such Entry Period will be considered. Entries from one Entry Period will not carry over to any subsequent Entry Period.
(c) There is only one (1) way to enter the Contest: via bluejays.com. No other method of entry will be accepted. To enter the Contest, go to www.bluejays.com/souvenirsfromtorontocontest during an Entry Period and click on the "Enter Now" button/link to access the online entry form for the Contest. During the Entry Period, complete the online entry form as instructed, including providing all required information, and submit the completed online entry form. By successfully transmitting a completed Entry (defined below) as directed, you will be entered in the Contest.

Each entry that is fully completed, complies with the foregoing requirements and is submitted in accordance with the instructions set forth above is referred to as an "Entry". Incomplete entries will be deemed void.
(d) MLBAM's computer shall be the official clock of the Contest with respect to Entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
(e) By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM's Terms of Use accessible at: mlb.com/tou and Privacy Policy accessible at: www.mlb.com/privacy. Information submitted by entrants on bluejays.com will also be provided to Sponsor and treated in accordance with Sponsor's Privacy Policy, available at www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant's consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant's chances of winning.

## 4. PRIZE DESCRIPTION:

A total of twenty (20) prizes will be awarded during the Contest Period (five (5) per Entry Period). Winners will each receive one (1) of the following prizes (the specific prize to be determined in the sole discretion of Sponsor):
(a) One (1) authentic game-used baseball (estimated retail value of CDN \$75.00)

## OR

(b) One (1) authentic vial of playing surface dirt (estimated retail value of CDN $\$ 25.00$ ).

The exact prize selected for each winner is at Sponsor's sole discretion. Any difference in value will not be awarded.

## 5. PRIZE CONDITIONS:

(a) Any and all Contest prizes must be accepted as awarded and may not be transferred, assigned, or redeemed for cash except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, any prize is provided "as is" without further warranty of any kind.
(b) All prize details, including the exact nature, type and quality of any items to be awarded will be determined in the sole discretion of Sponsor. Some restrictions may apply. A Certificate of Authenticity will not be provided by Sponsor. Actual value of any authenticated items is subject to market fluctuations. Any unused portion of the prize will be forfeited. Each winner is fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).

6. RANDOM DRAW: At approximately $10: 00 \mathrm{a} . \mathrm{m}$. ET on each of the draw dates set forth in the table in subsection 3(a), above, a Sponsor or MLBAM representative will select by random draw five (5) potential prize winners from among all eligible Entries received during the applicable Entry Period.

Limit of one (1) prize per person. Odds of winning a prize depend on the total number of eligible Entries received during the applicable Entry Period.
7. The Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. All disputes will be resolved in the Province of Ontario under applicable Ontario and Federal laws.

In the event of cancellation, Sponsor may elect to identify winners and award the Prizes by way of random drawing from among all non-suspect, eligible Entries received up to the time of such cancellation.
