

THESCORE BET BASES LOADED CONTEST (the “Contest”)
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR: The sponsor of this Contest is Score Media and Gaming Inc., 125 Queens Quay East, 9th Floor, Toronto, ON, Canada, M5A 0Z6. (“**Sponsor**”).

2. ELIGIBILITY:

- (a) The Contest is open only to residents of the Province of Ontario who are of age of legal majority at the time of entry.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) Rogers Blue Jays Baseball Partnership (“**RBJBP**”), owner of the *Toronto Blue Jays*TM Major League Baseball team (the “**Team**”), (iii) the MLB Entities (defined below), (iv) each of their respective parents, affiliated companies, and subsidiaries, and (v) any and all other companies associated with the Contest. The “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (the “**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor and RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor and RBJBP reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. HOW TO ENTER:

- (a) The Contest entry period begins at 10:00 a.m. Eastern Time (“**ET**”) on Thursday, May 4, 2023 and ends at 4:59 p.m. ET on Monday, October 2, 2023 (the “**Contest Period**”), and consists of four (4) individual entry periods, as outlined in the chart below (each, an “**Entry Period**”):

- (b) Limit of one (1) entry per person/email address during the Contest Period. By way of illustration, if two (2) or more otherwise eligible persons share a single email address, only one (1) of them

may enter the Contest during any Entry Period. If one (1) person has two (2) or more email accounts, that person may enter the Contest only once during an Entry Period and only the first entry received from such person will be considered.

For certainty, Entries (as defined below) from one Entry Period will carry over to subsequent Entry Periods.

- (c) There is one (1) way to enter to: via bluejays.com. No other method of entry will be accepted. To enter the Contest, during the applicable Entry Period go to www.bluejays.com/thescorebetcontest, complete the online entry form (the “**Entry Form**”) as instructed, including all required information, and submit the completed Entry Form for one (1) entry into the Contest (any such entry, an “**Online Entry**”). By successfully transmitting a completed Online Entry as directed, you will be entered in the Contest.
- (d) There are two (2) ways in which an entrant may obtain five (5) additional entries into the Contest during an Entry Period: (1) via opt-in; or (2) by email. No other method of obtaining additional entries will be accepted.

i. Via opt-in: An entrant will receive five (5) additional entries in this Contest upon submission of their Online Entry if, while completing the Entry Form during an Entry Period, they opt in to receive electronic commercial messages from Sponsor, including information, marketing materials, and newsletters, by clicking the corresponding box.

OR

ii. By email: An entrant will receive five (5) additional entries in this Contest if, subsequent to submission of their Online Entry and during the applicable Entry Period, they send an email to tbjcontest@bluejays.com that (i) has as its subject line “theScore Bet Bases Loaded Contest”, (ii) includes a maximum fifty (50) word description stating why they would like to win the Contest, and (iii) specifies the entrant’s full name, address, city, province, postal code, age and day and evening telephone numbers (such information to be identical to the information supplied by the entrant in their Online Entry). An email for five (5) additional entries must be received by RBJBP by no later than 4:59 p.m. ET on the end date / time referred to in the above chart for the applicable Entry Period. The literary quality of the maximum fifty (50) word submission will not be judged or otherwise used in any way in, and will have no effect on, the determination of the winners.

Additional entries obtained via opt-in or by email in accordance with the instructions set forth above are hereinafter referred to as “**Additional Entries**”. Online Entries and Additional Entries will be referred to herein collectively as “**Entries**”. There is a limit of five (5) Additional Entries per eligible entrant during the Contest Period, regardless of which method of obtaining Additional Entries is chosen.

- (e) MLBAM’s computer shall be the official clock of the Contest with respect to Entries and Entry Periods. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (f) By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM’s Terms of Use accessible at: mlb.com/tou and Privacy Policy accessible at: mlb.com/privacy. Information submitted by entrants on bluejays.com

will be provided to RBJBP and treated in accordance with RBJBP's Privacy Policy available at www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Limited information submitted by entrants on bluejays.com, such as email addresses of those entrants who have opted in to receive commercial electronic messages (such as emails) from Sponsor, or contact information that will be used to facilitate prize delivery may be provided to Sponsor, and will be treated in accordance with Sponsor's Privacy Policy available at thescore.bet/legal/privacy, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM, RBJBP, and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant's consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant's chances of winning. All information submitted by entrants via email is being collected by RBJBP, and will be treated in accordance with RBJBP's Privacy Policy, available at www.bluejays.com/privacy, subject to the entrants' stated preferences from time to time. Limited information submitted by entrants via email, such as contact information that will be used to facilitate prize delivery may be provided to Sponsor, will be treated in accordance with Sponsor's Privacy Policy available at thescore.bet/legal/privacy, subject to the entrants' stated preferences from time to time.

- (g) All information submitted by entrants offline is being collected by RBJBP or Sponsor and will be available to both parties. All such information will be treated by Sponsor in accordance with Sponsor's Privacy Policy available at thescore.bet/legal/privacy and by RBJBP in accordance with RBJBP's Privacy Policy, available at www.bluejays.com/privacy. Sponsor's and RBJBP's treatment of information is subject to each entrant's stated preferences from time to time.

4. PRIZE DESCRIPTION:

Four (4) prizes will be awarded (one (1) per Entry Period), as follows:

- (a) **Entry Period 1 Prize.** One (1) eligible first Entry Period entrant will receive one (1) prize consisting of (collectively, the "**Entry Period 1 Prize**"):
- (i) two (2) admission tickets (total) for the winner and one (1) guest (collectively, the "**Entry Period 1 Prize Participants**") to attend each of the Team's regular season baseball games scheduled to be played in Toronto, Ontario at *Rogers Centre*TM stadium (the "**Stadium**") from June 5, 2023 through October 1, 2023 (total of fifty six (56) baseball games) (collectively, the "**Entry Period 1 Games**");
 - (ii) two (2) Team-branded "replica" jerseys;
 - (iii) two (2) Team-branded baseball caps;

The total estimated retail value of the Entry Period 1 Prize is CAD \$10,560. Any difference in value will not be awarded.

- (b) **Entry Period 2 Prize.** One (1) eligible second Entry Period entrant will receive one (1) prize consisting of (the "**Entry Period 2 Prize**"):
- (i) two (2) admission tickets (total) for the winner and one (1) guest (collectively, the "**Entry Period 2 Prize Participants**") to attend the Team's road regular season baseball game scheduled to be played in Denver, Colorado on Saturday, September 2, 2023 (the "**Entry Period 2 Game**");

- (ii) round trip economy air transportation for the Prize Participants from Toronto, Ontario to Denver, Colorado departing on Friday, September 1, 2023 and returning on Sunday, September 3, 2023 (the “**Entry Period 2 Airfare**”). Note that transportation to Toronto, Ontario is not included in the prize;
- (iii) one (1) hotel room (standard double occupancy) for two (2) nights in Denver, Colorado, on Friday September 1, 2023 and Saturday, September 2, 2023, in a hotel to be determined by Sponsor (the “**Entry Period 2 Hotel**”);
- (iv) two (2) Team-branded “replica” baseball jerseys;
- (v) two (2) Team-branded “replica” baseball caps; and
- (vi) Five Hundred Canadian dollars (CAD \$500) (total) in spending money (via cheque) for the winner only.

The total estimated retail value of the Entry Period 2 Prize is CDN \$3,940.00. Any difference in value will not be awarded.

- (c) **Entry Period 3 Prize.** One (1) eligible third Entry Period entrant will receive one (1) prize consisting of (the “**Entry Period 3 Prize**”):
 - (i) twelve (12) admission tickets (total) for the winner and eleven (11) guests (collectively, the “**Entry Period 3 Prize Participants**”) to attend the Team’s regular season baseball game scheduled to be played in Toronto, Ontario at the Stadium on Friday, September 15, 2023 (the “**Entry Period 3 Game**”) in a Stadium luxury suite;
 - (ii) six (6) hotel rooms (standard double occupancy) for one (1) night in in a hotel in Toronto, Ontario (the “**Entry Period 3 Hotel**”), on September 15, 2023;
 - (iii) twelve (12) Team-branded “replica” jerseys;
 - (iv) twelve (12) Team-branded baseball caps; and
 - (v) subject to Section 5 of these Official Rules, round trip economy air transportation for the Entry Period 3 Prize Participants from the international airport within Canada closest to the winner’s residence (as determined in the sole discretion of RBJBP) to Toronto, Ontario on travel dates to be determined by RBJBP (the “**Entry Period 3 Airfare**”);

The total estimated retail value of the Entry Period 3 Prize is CDN \$16,900 (inclusive of the Entry Period 3 Airfare) Actual retail value of the Entry Period 3 Prize will depend on whether the winner resides within 300 kilometres of the Stadium (in which case Entry Period 3 Airfare will not be provided, as more particularly set out in Section 5 of these Official Rules, below) and, if the winner resides further than 300 kilometres of the Stadium, on the winner’s departure city (the estimated retail value of the Entry Period 3 Airfare is based on the departure city of Ottawa, Ontario) Any difference in value will not be awarded.

- (d) **Entry Period 4 Prize.** One (1) eligible fourth Entry Period entrant will receive one (1) prize consisting of (the “**Entry Period 4 Prize**”):

- (i) two (2) admission tickets (total) for the winner and one (1) guest (collectively, the “**Entry Period 4 Prize Participants**”) to attend each of the Team’s regular season baseball games scheduled to be played at the Stadium during the 2024 Major League Baseball regular season (the “**Entry Period 4 Games**”);
- (ii) two (2) Team-branded “replica” jerseys; and
- (iii) two (2) Team-branded baseball caps.

The total estimated retail value of the Entry Period 4 Prize is CDN \$16,700.00. Any difference in value will not be awarded.

For the purposes of these Official Rules:

- I. The Entry Period 1 Prize, the Entry Period 2 Prize, the Entry Period 3 Prize, the, and the Entry Period 4 Prizes shall each be referred to as a “**Prize**” and collectively referred to as the “**Prizes**”;
- II. The Entry Period 1 Prize Participants, the Entry Period 2 Prize Participants, the Entry Period 3 Prize Participants, the Entry Period 4 Prize Participants shall each be referred to as a “**Prize Participant**” and collectively referred to as the “**Prize Participants**”;
- III. The Entry Period 1 Games, the Entry Period 2 Game, the Entry Period 3 Game and the Entry Period 4 Games shall each be referred to as a “**Game**” and collectively referred to as the “**Games**”;
- IV. The Entry Period 2 Airfare and the Entry Period 3 Airfare shall each be referred to as the “**Airfare**”; and
- V. The Entry Period 2 Hotel and the Entry Period 3 Hotel shall each be referred to as the “**Hotel**”.

5. PRIZE CONDITIONS:

- (a) If the winner of the Entry Period 3 Prize resides within 300 kilometres of the Stadium, the Entry Period 3 Airfare will not be awarded and the Entry Period 3 Prize Participants will be solely responsible for all costs of transportation and accommodation (and no additional compensation or substitution will be awarded for any difference in Entry Period 3 Prize value).
- (b) Any and all Contest Prizes must be accepted as awarded and may not be transferred, resold, commercially traded, assigned, or redeemed for cash except at Sponsor’s and RBJBP’s sole and absolute discretion. Sponsor and RBJBP reserve the right to substitute any stated Prize (or portion thereof) with an alternate prize of comparable or greater value at their sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, any Prize is provided “as is” without further warranty of any kind.
- (c) Participation in any Prize may be subject to the applicable Prize Participant’s consent to and compliance with all health and safety policies of the MLB Entities, which may included, but are not limited to, the wearing of masks if and when directed and the requirement to be fully vaccinated against COVID-19.
- (d) All Prize details, including any Airfare and ground transportation times (if applicable), seat locations for any Game, the location of the Hotel, and the exact nature and type of any merchandise

awarded will be determined in the sole discretion of Sponsor and/or RBJBP. Some restrictions may apply. Any Airfare, Hotel and ground transportation travel arrangements (if applicable) must be made through Sponsor's agent on a carrier of Sponsor's choice and tickets will be subject to those terms and conditions specified by the ticket issuers. In addition, the applicable Prize Participants must travel together on the same itinerary and are responsible for ensuring they have all necessary travel documents (e.g., valid passport and valid proof of vaccination). RBJBP, Sponsor and the MLB Entities are not responsible in the event any Prize Participant is refused boarding at any time by any airline or airport security, including as a result of any applicable health and safety requirements (for example, vaccination requirements, mask-wearing requirements, etc.), applicable laws, or regulations. Any unused portion of a Prize (including as a result of any Prize Participant being refused Airfare or ground transportation boarding) will be forfeited. Each Prize Participant must be of age of legal majority in the Province of Ontario. The winners are fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).

- (e) Use of any Major League Baseball game/event/exhibition ticket is subject to standard terms, conditions, and health and safety policies applicable to the ticket; see <https://www.mlb.com/tickets/terms-and-conditions> and <https://www.bluejays.com/ticketterms> for details. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of each Prize, if applicable, will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The winners and their guests agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the Prize, if applicable. The applicable MLB Entities reserve the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages, epidemic, pandemic, or any other issue concerning public health or safety, or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of each Prize, if applicable, may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.
- (f) Any and all additional costs and expenses associated with Prize acceptance and use not specified herein as being provided including but not limited to travel and health insurance; unless explicitly provided as part of the applicable Prize, transportation costs (including checked baggage fees, excess baggage fees, and transportation to and from the airport, and transportation to and from the Game(s)), lodging and meals not specifically referenced in the applicable Prize, gratuities and other expenses incurred by the winners (and any guests) in claiming, accepting and/or using the applicable Prize are the sole responsibility of each individual winner.

6. RANDOM DRAW: At approximately 10:00 a.m. ET on each of the draw dates identified in the table in subsection 3(a), above, (each, a “**Draw Date**”), an RBJBP representative, or other person designated by RBJBP, will select by random draw one (1) prize winner for the applicable Entry Period from among all eligible Entries received during the preceding Entry Periods. Limit of one (1) Prize per person. For certainty, unselected Entries from one Entry Period will carry over to each subsequent Entry Period (if any).

Odds of winning depend on the number of eligible Entries received during each applicable Entry Period.

7. NOTIFICATION: Each potential winner selected in accordance with the previous section will be notified as follows:

- (a) If the Entry submitted by the potential winner was submitted via www.bluejays.com, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her/their Entry to determine if he/she/they is/are eligible in the sole discretion of the RBJBP representative.
- (b) If the Entry submitted by the potential winner was submitted via email, the potential winner will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her/their Entry to determine if he/she/they is/are eligible, in the sole discretion of the RBJBP representative.

In the event that any potential winner does not respond to such notification within five (5) business days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor or RBJBP in its sole discretion or declines a Prize for any reason, they will be disqualified, the applicable Prize will be forfeited and, at Sponsor's and RBJBP's discretion and time permitting, an alternate potential winner of the applicable Prize may be randomly selected from among all remaining eligible Entries received during the Entry Period.

8. DECLARING A WINNER:

- (a) To be declared a winner and claim the Prize awarded, a potential winner must (i) be eligible according to these Official Rules, (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time limited mathematical skill testing question which will be administered by telephone at a mutually agreeable time, and (iii) sign a duly completed Liability and, except where prohibited by law, Publicity Release form, and any other documentation as may reasonably be required by Sponsor and/or RBJBP (including, without limitation, any release forms to be completed by any Prize Participants), and return same to Sponsor (or if directed, RBJBP) by the date specified on the applicable documentation.
- (b) If all required documents are not properly executed and returned within the specified period of time, or the potential winner otherwise fails to comply with these Official Rules, a disqualification will result and the prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries. Each winner's guest must also sign a duly completed Liability and, except where prohibited by law, Publicity Release form and return same to Sponsor (or, if directed, RBJBP) by the date specified in order to participate in the prize.

9. WAIVER OF LIABILITY/PUBLICITY RELEASE:

- (a) By participating in the Contest and submitting an Entry, each entrant (i) agrees to be bound by these Official Rules, including all Entry requirements, (ii) agrees that the decisions of Sponsor and RBJBP are final and without appeal, (iii) remises, releases and forever discharges Sponsor, RBJBP, the other MLB Entities, Facebook, Inc. ("**Facebook**"), Instagram, Inc. ("**Instagram**"), Twitter, Inc. ("**Twitter**"), each of their respective parents, affiliated companies and subsidiaries, any and all other companies associated with the Contest (including prize suppliers and suppliers of materials or services related to the Contest), and all of their respective employees, directors, officers, shareholders, agents, representatives, successors and assigns (collectively, the "**Released Parties**") from any and all actions, causes of actions, suits, debts, dues, accounts, claims, damages, liability,

losses, harm, costs or expenses, including without limitation any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, arising out of, or in any way related to, directly or indirectly, the Contest, including without limitation the entrant's participation in the Contest, any breach of these Official Rules, the awarding, receipt, possession, use and/or misuse of any Contest Prize (or any portion thereof), and any travel or activity that is related to the receipt or use of any Contest Prize, and/or the violation or infringement of any intellectual property rights or of any publicity, personality or privacy rights, and agrees to fully indemnify the Released Parties, Instagram, Twitter, and Facebook from any and all claims by third parties relating to the foregoing.

- (b) By accepting a Prize, each winner authorizes Sponsor, RBJBP, MLBAM, the other MLB Entities and each of their respective designees to use in any related publicity, such winner's name, city and province/territory of residence, photograph, image, likeness, voice, and any statements he/she may make regarding such Prize for advertising and promotional purposes worldwide in perpetuity and in any form of media now or hereafter devised worldwide (including the Internet), without limitation and without additional compensation or consideration, notification or permission, unless prohibited by law; and waives any rights that may exist in respect of materials produced pursuant to the foregoing.

10. GENERAL CONTEST TERMS AND CONDITIONS:

- (a) The Released Parties are not responsible for (i) stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due or garbled entries, transmissions, email or mail; (ii) lost, interrupted or unavailable network, cable, satellite, server, Internet Service Provider, website, or other connections including those through and/or by any website; (iii) availability or accessibility or miscommunications or failed computer, satellite, telephone, cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (iv) failures or malfunctions of phones, phone lines or telephone systems, (v) any error, omission, interruption, defect or delay in transmission, processing, or communication; (vi) non-delivery of any communication or Entry; (vii) misdirected, blocked, or delayed email notifications; (viii) printing, typographical or other errors appearing within these Official Rules, in any Contest-related advertisements or other materials; (ix) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, mail, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of Entries, the announcement of any Prize in any Contest-related materials, or the cancellation or postponement of any Major League Baseball game, event or exhibition, (x) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest; or (xi) any injury or damage to the computer of any entrant or other person related to or resulting from participating in this Contest or downloading materials from or use of any website.
- (b) Persons who tamper with or abuse any aspect of the Contest or website or attempt to undermine the legitimate operation of the Contest by cheating, deception or other unfair playing practices, or intend to annoy, abuse, threaten or harass any other entrant or Sponsor's or RBJBP's representatives or who are in violation of these Official Rules, as solely determined by Sponsor and/or RBJBP, will be disqualified and all associated Entries will be void. Any attempt to deliberately damage the content or operation of this Contest is unlawful and subject to legal action by Sponsor, RBJBP, MLBAM and/or their respective agents. Sponsor and RBJBP shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws

relating to the Contest, and to resolve all disputes in their sole discretion. The Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize, and (ii) disclaim any implied warranty. The failure of Sponsor, RBJBP or MLBAM to enforce any term of these Official Rules shall not constitute a waiver of that provision. All disputes will be resolved in the Province of Ontario under applicable Ontario and Federal laws.
