# THE 2023 TORONTO BLUE JAYS<sup>™</sup> 7 DAYS OF GIVEAWAYS CONTEST (the "Contest")

#### **OFFICIAL RULES**

# NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSOR: The sponsor of this Contest is Rogers Blue Jays Baseball Partnership, located at One Blue Jays Way, Suite 3200, Toronto, Ontario M5V 1J1 ("Sponsor"), owner of the *Toronto Blue Jays*™ Major League Baseball team (the "Team").

## 2. ELIGIBILITY:

- (a) The Contest is open only to residents of Canada, excluding the Province of Quebec who are of age of legal majority in the province/territory in which they reside at the time of entry.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) the other MLB Entities (defined below), (iii) each of their respective parents, affiliated companies, and subsidiaries, and (iv) any and all other companies associated with the Contest. The "MLB Entities" shall mean the Office of the Commissioner of Baseball (the "BOC"), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. ("MLBAM"), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the "Clubs"), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof to the complete satisfaction of Sponsor may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

## **3. HOW TO ENTER:**

(a) The Contest entry period begins at 10:00 a.m. Eastern Time ("ET") on Friday, December 1, 2023 and ends at 7:59 p.m. ET on Thursday, December 7, 2023 (the "Contest Period"), and consists of seven (7) individual entry periods, as outlined in the chart below (each, an "Entry Period"):

- (b) <u>Limit of one (1) Entry (defined below) per person/email address per Entry Period.</u> By way of illustration, if two (2) or more otherwise eligible persons share a single email address, only one (1) of them may enter the Contest during any Entry Period. If one (1) person has two (2) or more email accounts that person may enter the Contest only once during any Entry Period and only the first Entry (defined below) received from such person will be considered. <u>Non-Drawn eligible Entries from one (1) Entry Period will not carry over to any subsequent Entry Period (if any)</u>.
- (c) There is only one (1) way to enter the Contest: online via bluejays.com. No other method of entry will be accepted. During an Entry Period, go to <u>www.bluejays.com/holijays</u> to access the online entry form for the Contest, and submit a completed online entry form as instructed, including all required information. By successfully transmitting a completed Entry (defined below) as directed, you will be entered in the Contest for that applicable Entry Period. Each entry that is fully completed, complies with the foregoing requirements and is submitted in accordance with the instructions set forth above is referred to as an "Entry". Incomplete entries will be deemed void.
- (d) MLBAM's computer shall be the official clock of the Contest with respect to Entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (e) By entering this Contest, each entrant consents to the collection, use, and disclosure of their personal information for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM's Terms of Use accessible at: <u>mlb.com/tou</u> and Privacy Policy accessible at: <u>mlb.com/privacy</u>. Information submitted by entrants on bluejays.com will be provided to Sponsor and treated in accordance with Sponsor's Privacy Policy available at <u>www.bluejays.com/privacy</u>, subject to the entrants' stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant's consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant's chances of winning.
- (f) All information submitted by entrants offline is being collected by and will be available to Sponsor. All such information will be treated by Sponsor in accordance with its Privacy Policy available at <u>www.bluejays.com/privacy</u>. Sponsor's treatment of information is subject to each entrant's stated preferences from time to time.
- 4. **PRIZE DESCRIPTION:** A total of three hundred and seven (307) prizes will be awarded during the Contest Period, consisting of seven (7) primary prizes and three hundred (300) secondary prizes, as follows:
  - (i) Entry Period 1:

- (A) One (1) primary prize will be awarded in connection with Entry Period 1 (the "Day 1 Primary Prize"). The Day 1 Primary Prize winner will receive one (1) five hundred dollar (CAD \$500) Jays Shop<sup>™</sup> gift card, such gift card subject to the terms and conditions associated with its use. The retail value of the Day 1 Primary Prize is five hundred dollars (CAD \$500).
- (B) Fifty (50) secondary prizes will be awarded in connection with Entry Period 1 (each, a "Day 1 Secondary Prize"). Day 1 Secondary Prize winners will each receive one (1) Team-branded toque. The estimated retail value of each Day 1 Secondary Prize is twenty-four dollars and ninety-nine cents (CAD \$29.99). Any difference in value will not be awarded.

## (ii) Entry Period 2:

- (A) One (1) primary prize will be awarded in connection with Entry Period 2 (the "Day 2 Primary Prize"). The Day 2 Primary Prize winner will receive one (1) package consisting of one (1) of each of the promotional giveaway items distributed by the Team in connection with 2024 Team home regular season games (the "Giveaway Items"), up to a maximum of twenty-one (21) Giveaway Items. A full list of Giveaway Items will be available at <u>https://www.mlb.com/bluejays/tickets/promotions/schedule</u>. Giveaway Items do not include any promotional items given away as part of any specialty ticket package or other ticket package. Specific Giveaway Items forming part of the Day 2 Primary Prize in the sole discretion of Sponsor. The estimated retail value of the Day 2 Primary Prize is five hundred dollars (CAD \$500). Any difference in value will not be awarded.
- (B) Twenty-five (25) secondary prizes will be awarded in connection with Entry Period 2 (each, a "Day 2 Secondary Prize"). Day 2 Secondary Prize winners will each receive one (1) autographed photo of one or more Team player(s) (specific player(s) to be determined by the Sponsor in its sole discretion). The estimated retail value of each Day 2 Secondary Prize is fifty dollars (CAD \$50). Any difference in value will not be awarded.

## (iii) Entry Period 3:

- (A) One (1) primary prize will be awarded in connection with Entry Period 3 (the "Day 3 Primary Prize"). The Day 3 Primary Prize winner will receive one (1) one thousand dollar (CAD \$1,000) Jays Shop gift card, such gift card subject to the terms and conditions associated with its use. The retail value of the Day 3 Primary Prize is one thousand dollars (CAD \$1,000).
- (B) Fifty (50) secondary prizes will be awarded in connection with Entry Period 3 (each, a "Day 3 Secondary Prize"). Day 3 Secondary Prize winners will each receive one (1) Team-branded adjustable replica hat. The estimated retail value of each Day 3 Secondary Prize is twenty-four dollars and ninety-nine cents (CAD \$24.99). Any difference in value will not be awarded.

## (iv) Entry Period 4:

(A) One (1) primary prize will be awarded in connection with Entry Period 4 (the "**Day 4 Primary Prize**"). The Day 4 Primary Prize winner will receive:

- (1) two (2) admission tickets (total) for the Day 4 Primary Prize winner and one (1) guest (collectively, the "Day 4 Primary Prize Participants") to attend a Team 2024 regular season home game (a "Game") in Toronto, Ontario at the Stadium on a date selected by the Sponsor. Transportation to and from Toronto, Ontario, hotel accommodations in Toronto, Ontario and ground transportation to and from the applicable Game are not included, and
- (2) dinner for winner and guest at the *Ticketmaster Lounge* at the Stadium before the Game.

The estimated retail value of the Day 4 Primary Prize is five hundred dollars (CAD \$500). Any difference in value will not be awarded.

(B) Fifty (50) secondary prizes will be awarded in connection with Entry Period 4 (each, a "Day 4 Secondary Prize"). Day 4 Secondary Prize winners will each receive one (1) Team-branded adjustable baseball cap. The estimated retail value of each Day 4 Secondary Prize is twenty-four dollars and ninety-nine cents (CAD \$24.99). Any difference in value will not be awarded.

#### (v) Entry Period 5:

- (A) One (1) primary prize will be awarded in connection with Entry Period 5 (the "Day 5 Primary Prize"). The Day 5 Primary Prize winner will receive one (1) baseball autographed by one (1) Team player, one (1) baseball bat autographed by one (1) Team player and one (1) jersey autographed by one (1) Team player (specific Team player in each case in sole discretion of Sponsor). The estimated retail value of the Day 5 Primary Prize is six hundred and fifty dollars (CAD \$650). Any difference in value will not be awarded.
- (B) Fifty (50) secondary prizes will be awarded in connection with Entry Period 5 (each, a "Day 5 Secondary Prize"). Day 5 Secondary Prize winners will each receive one (1) Team-branded scarf. The estimated retail value of each Day 5 Secondary Prize is twenty-five dollars (CAD \$24.99). Any difference in value will not be awarded.

#### (vi) **Entry Period 6:**

- (A) One (1) primary prize will be awarded in connection with Entry Period 6 (the "Day 6 Primary Prize"). The Day 6 Primary Prize winner will receive eight (8) admission tickets (total) to a luxury suite for the Day 6 Primary Prize winner and seven (7) guests (collectively, the "Day 6 Primary Prize Participants") to attend a Game in Toronto, Ontario at the Stadium on a date selected by the Sponsor. The type of luxury suite will be selected by the Sponsor in its sole discretion. Transportation to and from Toronto, Ontario, hotel accommodations in Toronto, Ontario, ground transportation to and from the applicable Game, food and beverage, and host/hostess service are not included. The estimated retail value of the Day 6 Primary Prize is two thousand dollars (CAD \$2,000). Any difference in value will not be awarded.
- (B) Fifty (50) secondary prizes will be awarded in connection with Entry Period 6 (each, a "Day 6 Secondary Prize"). Day 6 Secondary Prize winners will each receive one (1) vial of authenticated Stadium infield dirt. The estimated retail value of each Day 6 Secondary

Prize is twenty-four dollars and ninety-nine cents (CAD \$29.99). Any difference in value will not be awarded.

- (vii) **Entry Period 7:** 
  - (A) One (1) primary prize will be awarded in connection with Entry Period 7 (the "Day 7 Primary Prize"). The Day 7 Primary Prize winner will receive:
    - (1) one (1) one thousand five hundred dollar (CAD \$1,500) *Jays Shop* gift card, such gift card subject to the terms and conditions associated with its use; and
    - (2) one (1) Ryobi tool kit.

The retail value of the Day 7 Primary Prize is one thousand eight hundred fifty dollars (CAD \$1,850).

(B) Twenty-five (25) secondary prizes will be awarded in connection with Entry Period 7 (each, a "Day 7 Secondary Prize"). Day 7 Secondary Prize winners will each receive one (1) baseball autographed by one (1) Team player (specific player determined by Sponsor). The estimated retail value of each Day 7 Secondary Prize is two hundred and fifty dollars (CAD \$150). Any difference in value will not be awarded.

The Day 1 Primary Prize, the Day 1 Secondary Prizes, the Day 2 Primary Prize, the Day 2 Secondary Prizes, the Day 3 Primary Prize, the Day 3 Secondary Prizes, the Day 4 Primary Prize, the Day 4 Secondary Prizes, the Day 5 Primary Prize, the Day 5 Secondary Prizes, the Day 6 Primary Prize, the Day 6 Secondary Prizes, the Day 7 Primary Prize, and the Day 7 Secondary Prizes are hereafter collectively referred to as the "**Prizes**".

The Day 4 Primary Prize Participants and the Day 6 Primary Prize Participants are hereafter collectively referred to as "**Prize Participants**".

Limit of one (1) Prize per person, per Entry Period.

## 5. PRIZE CONDITIONS:

- (a) With respect to any Prize which includes tickets and/or access to a Stadium luxury suite to a Game:
  - (i) Transportation to and from Toronto, Ontario, hotel accommodations in Toronto, Ontario, and ground transportation to and from the applicable Game are not included. The Prize Participants will be solely responsible for all costs of transportation and accommodation (and no additional compensation or substitution will be awarded for any difference in prize value), and
  - (ii) Participation in the Prize is subject to winner's (and each Prize Participants') consent to and compliance with all health and safety policies of the MLB Entities and the Sponsor.
- (b) Any and all Contest Prizes must be accepted as awarded and may not be transferred, resold, commercially traded, assigned, or redeemed for cash except at Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute any stated Prize (or portion thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, each Prize is provided "as is" without further warranty of any kind.

- (c) All Prize details, including the exact nature, type and quality of any items to be awarded, and, as applicable, Game seat locations, will be determined in the sole discretion of Sponsor. Some restrictions may apply. Actual value of any authenticated item is subject to market fluctuations. Unless otherwise expressly stated in these Official Rules, authenticated items are not game used and no Certificate of Authenticity will be provided. Any unused portion of a Prize will be forfeited. Each winner is fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).
- (d) Use of any Major League Baseball game/event/exhibition ticket is subject to standard terms, conditions, and health and safety policies applicable to the ticket; see bluejays.com/ticketterms for details. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the applicable Prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The winner(s) and their guest(s) agree to comply with all applicable stadium and applicable, regulations in connection with the applicable Prize; venue, as see bluejays.com/ticketterms for details. The applicable MLB Entities reserve the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages, epidemic, pandemic, or any other issue concerning public health or safety, or any other event outside their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of a Prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and Prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.
- (e) Any and all additional costs and expenses associated with Prize acceptance and use not specified herein as being provided including, as applicable, transportation to and from a Game, lodging, meals, gratuities, and other expenses incurred by the winner(s) and any guests in claiming, accepting and/or using a Prize are the sole responsibility of each individual winner.
- (f) Actual value of each autographed item is subject to market fluctuations. No certificate of authenticity is provided by Sponsor. Item is not used.
- 6. **RANDOM DRAW:** Following each Entry Period, at approximately 10:00 a.m. ET on each of the draw dates set forth in the table in subsection 3(a), above, a Sponsor representative, or other person designated by Sponsor will select by random draw, as applicable:
  - (a) One (1) potential Day 1 Primary Prize winner followed by fifty (50) potential Day 1 Secondary Prize Winners from among all eligible Entries received during Entry Period 1;
  - (b) One (1) potential Day 2 Primary Prize winner followed by twenty five (25) potential Day 2 Secondary Prize Winners from among all eligible Entries received during Entry Period 2;
  - (c) One (1) potential Day 3 Primary Prize winner followed by fifty (50) potential Day 3 Secondary Prize Winners from among all eligible Entries received during Entry Period 3;
  - (d) One (1) potential Day 4 Primary Prize winner followed by fifty (50) potential Day 4 Secondary Prize Winners from among all eligible Entries received during Entry Period 4;

- (e) One (1) potential Day 5 Primary Prize winner followed by fifty (50) potential Day 5 Secondary Prize Winners from among all eligible Entries received during Entry Period 5;
- (f) One (1) potential Day 6 Primary Prize winner followed by fifty (50) potential Day 6 Secondary Prize Winners from among all eligible Entries received during Entry Period 6; and
- (g) One (1) potential Day 7 Primary Prize winner followed by twenty-five (25) potential Day 7 Secondary Prize Winners from among all eligible Entries received during Entry Period 7.

Limit one (1) Prize per person, per Entry Period. Odds of winning depend on the number of eligible Entries received during the applicable Entry Period.

7. NOTIFICATION: Each potential winner selected in accordance with the previous section will be contacted by a Sponsor representative by telephone at the telephone number indicated in their Entry to determine if they are eligible in the sole discretion of the Sponsor representative. In the event that any potential winner does not respond to such notification within two (2) business days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor in its sole discretion or declines a Prize for any reason, they will be disqualified, the Prize will be forfeited and, at Sponsor's discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries received during the applicable Entry Period.

# 8. DECLARING THE WINNERS:

- (a) To be declared a winner and claim a Prize, a potential winner must (i) be eligible according to these Official Rules, (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time limited mathematical skill testing question which will be administered by telephone at a mutually agreeable time, and (iii) sign a duly completed Liability and, except where prohibited by law, Publicity Release form, and any other documentation as may reasonably be required by Sponsor, and return same to Sponsor by the date specified on the applicable documentation.
- (b) If all required documents are not properly executed and returned within the specified period of time, or the applicable potential winner otherwise fails to comply with these Official Rules, a disqualification will result and the applicable Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries received during the applicable Entry Period.
- (c) In addition to the requirements set forth above, the winner of the Day 6 Primary Prize will also be required to sign a duly completed Rogers Stadium Limited Partnership ("**RSLP**") (owner of the Stadium) 2023 *Toronto Blue Jays* Regular Season Luxury Suite License Agreement and return same to Sponsor by the date specified on the applicable documentation.

## 9. WAIVER OF LIABILITY/PUBLICITY RELEASE:

(a) By participating in the Contest and submitting an Entry, each entrant (i) agrees to be bound by these Official Rules, including all Entry requirements, (ii) agrees that the decisions of Sponsor are final and without appeal, (iii) remises, releases and forever discharges Sponsor, the other MLB Entities, RSLP, Facebook, Inc. ("Facebook"), Instagram, Inc. ("Instagram"), Twitter, Inc. ("Twitter"), Fanatics, Inc., each of their respective parents, affiliated companies and subsidiaries, any and all other companies associated with the Contest (including prize suppliers and suppliers of materials or services related to the Contest), and all of their respective employees, players, coaches, alumni, directors, officers, shareholders, agents, representatives, successors and assigns (collectively, the "Released Parties") from any and all actions, causes of actions, suits, debts, dues, accounts, claims, damages, liability, losses, harm, costs or expenses, including without limitation any and all liability

for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, arising out of, or in any way related to, directly or indirectly, the Contest, including without limitation the entrant's participation in the Contest, any breach of these Official Rules, the awarding, receipt, possession, use and/or misuse of a Contest Prize (or any portion thereof), and, if applicable, any travel or activity that is related to the receipt or use of a Contest Prize, and/or the violation or infringement of any intellectual property rights or of any publicity, personality or privacy rights, and agrees to fully indemnify the Released Parties, Instagram, Twitter and Facebook from any and all claims by third parties relating to the foregoing.

(b) By accepting a Prize, each winner authorizes Sponsor, MLBAM, the other MLB Entities, and each of their respective designees to use in any related publicity, such winner's name, city and province/territory of residence, photograph, image, likeness, voice, and any statements they may make regarding such Prize for advertising and promotional purposes worldwide in perpetuity and in any form of media now or hereafter devised worldwide (including the Internet), without limitation and without additional compensation or consideration, notification or permission, unless prohibited by law; and waives any rights that may exist in respect of materials produced pursuant to the foregoing.

#### 10. GENERAL CONTEST TERMS AND CONDITIONS:

- (a) The Released Parties are not responsible for (i) stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due or garbled entries, transmissions, email or mail; (ii) lost, interrupted or unavailable network, cable, satellite, server, Internet Service Provider, website, or other connections including those through and/or by any website; (iii) availability or accessibility or miscommunications or failed computer, satellite, telephone, cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (iv) failures or malfunctions of phones, phone lines or telephone systems, (v) any error, omission, interruption, defect or delay in transmission, processing, or communication; (vi) nondelivery of any communication or Entry; (vii) misdirected, blocked, or delayed email notifications; (viii) printing, typographical or other errors appearing within these Official Rules, in any Contestrelated advertisements or other materials; (ix) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, mail, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of Entries, the announcement of any Prize in any Contest-related materials, or the cancellation or postponement of any Major League Baseball game, event or exhibition, (x) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest; or (xi) any injury or damage to the computer of any entrant or other person related to or resulting from participating in this Contest or downloading materials from or use of any website.

Any attempt to deliberately damage the content or operation of this Contest is unlawful and subject to legal action by Sponsor, MLBAM and/or their respective agents. Sponsor shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Contest, and to resolve all disputes in its sole discretion. The Released Parties (i) make no warranty, guaranty or representation of any kind concerning any Prize,
