

NERF / *BLUE JAYS*[™] CONTEST (the “Contest”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR:** The sponsor of this Contest is Hasbro Canada Corp., 2350 Rue de la Province, Longueuil, Quebec, J4G 1G2 (“**Sponsor**”).

2. **ELIGIBILITY:**

- (a) To be eligible to enter the Contest, you must: (i) be a legal resident of Canada; (ii) be of age of legal majority in the province/territory in which you reside at the time of entry; and (iii) be the parent or legal guardian of a child who is not younger than six (6) years of age or older than fourteen (14) years of age as of Wednesday, June 12, 2024 (each, a “**Child**”).
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) Sponsor, (ii) Rogers Blue Jays Baseball Partnership (“**RBJBP**”), owner of the *Toronto Blue Jays*[™] Major League Baseball team (the “**Team**”), (iii) the other MLB Entities (defined below), (iv) each of their respective parents, affiliated companies, and subsidiaries, and (v) any and all other companies associated with the Contest. The “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (the “**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) Sponsor and RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. Sponsor and RBJBP reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. **HOW TO ENTER:**

- (a) The Contest entry period begins at 10:00 a.m. Eastern Time (“**ET**”) on Wednesday, June 12, 2024, and ends at 4:59 p.m. ET on Wednesday, July 17, 2024 (the “**Entry Period**”).
- (b) Limit of one (1) Online Entry (defined below) per person/email address, per Child, regardless of the method of entry. By way of illustration, if two (2) or more otherwise eligible persons share a single email address, only one (1) of them may enter the Contest. If one (1) person has two (2) or more email accounts, that person may enter the Contest only once and only the first Online Entry received from such person will be considered.
- (c) There is one (1) way to enter: via bluejays.com. No other method of entry will be accepted. During the Entry Period go to www.bluejays.com/NerfContest to access the online entry form for the Contest. During the Entry Period, complete the online entry form (an “**Entry Form**”) as instructed, including all required information, and submit the completed Entry Form (any such entry, an “**Online Entry**”). By successfully transmitting a completed Online Entry as directed, you will be entered in the Contest.

- (d) There are two (2) ways in which an entrant may obtain five (5) additional entries into the Contest: (i) via opt-in, or (ii) by email. No other method of obtaining additional entries will be accepted.

i. Via opt-in: An entrant will receive five (5) additional entries in this Contest upon submission of their Online Entry if, while completing the Entry Form, they opt in to receive electronic commercial messages from Sponsor, including information, promotions, and offers, by clicking the corresponding box.

OR

ii. By email: An entrant will receive five (5) additional entries in this Contest if, subsequent to submission of their Online Entry, they send an email to tbjcontest@bluejays.com that (A) has as its subject line “Nerf / Blue Jays Contest”, (B) includes a maximum fifty (50) word description stating why they would like to win the Contest, and (C) specifies the entrant’s full name, address, city, province, postal code, age and day and evening telephone numbers (such information to be identical to the information supplied by the entrant in their Online Entry). An email for five (5) additional entries must be received by RBJBP by no later than 4:59 p.m. ET on Wednesday, July 17, 2024. The literary quality of the maximum fifty (50) word submission will not be judged or otherwise used in any way in, and will have no effect on, the determination of the winners.

Additional entries obtained via opt-in or by email in accordance with the instructions set forth above are hereinafter referred to as “**Additional Entries**”. Online Entries and Additional Entries will be referred to herein collectively as “**Entries**”. There is a limit of five (5) Additional Entries per person/email address, per Child, regardless of which method of obtaining Additional Entries is chosen. Incomplete entries will be deemed void.

- (e) MLBAM’s computer shall be the official clock of the Contest with respect to Entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to create and/or submit any Entry.
- (f) By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her/their personal information, and that of their Child, for the purposes and in the manner described herein. All information submitted by entrants on bluejays.com is being collected by MLBAM and is subject to, and will be treated in a manner consistent with, MLBAM’s Terms of Use accessible at: mlb.com/tou and Privacy Policy accessible at: mlb.com/privacy. Information submitted by entrants on bluejays.com will be provided to RBJBP and treated in accordance with RBJBP’s Privacy Policy available at www.bluejays.com/privacy, subject to the entrants’ stated preferences from time to time. Limited information submitted by entrants on bluejays.com, such as email addresses of those entrants who have opted in to receive commercial electronic messages (such as emails) from Sponsor, or contact information that will be used to facilitate prize delivery may be provided to Sponsor, and will be treated in accordance with Sponsor’s Privacy Policy available at <https://docs.hasbro.com/en-ca/legal/privacy>, subject to the entrants’ stated preferences from time to time. Online entrants may be given the option to receive commercial electronic messages (e.g., emails) and/or other communications from MLBAM, RBJBP, and/or Sponsor; however, eligibility to participate in the Contest is not dependent upon an entrant’s consent to receive such messages and communications and consenting to receive such messages and communications will not impact an entrant’s chances of winning.
- (g) All information submitted by entrants offline is being collected by RBJBP or Sponsor and will be available to both parties. All such information will be treated by Sponsor in accordance with

Sponsor's Privacy Policy available at <https://docs.hasbro.com/en-ca/legal/privacy> and by RBJBP in accordance with RBJBP's Privacy Policy, available at www.bluejays.com/privacy. Sponsor's and RBJBP's treatment of information is subject to each entrant's stated preferences from time to time.

4. PRIZE DESCRIPTION:

Eleven (11) total prizes will be awarded (one (1) Grand Prize (defined below) and ten (10) Secondary Prizes (defined below)) as follows:

- (a) **Grand Prize:** One (1) eligible entrant will win one (1) grand prize (the "**Grand Prize**") consisting of:
 - (i) four (4) admission tickets (total) for the winner, the Child and two (2) guests (collectively, the "**Prize Participants**") to attend two (2) of the Team's 2024 regular season baseball games scheduled to be played in Toronto (the "**Destination**") at *Rogers Centre*TM stadium (the "**Stadium**") on Saturday, August 10, 2024 and Sunday, August 11, 2024 (each, a "**Game**" and collectively, the "**Games**") (estimated retail value of CAD \$2,000);
 - (ii) one (1) hotel room (standard quad occupancy) for three (3) nights in the Destination in a hotel and on dates to be determined by Sponsor (the "**Hotel**") (estimated retail value of CAD \$1500);
 - (iii) four (4) replica Team-branded jerseys (estimated retail value of CAD \$880);
 - (iv) two hundred dollars (CAD \$200) worth of food and non-alcoholic beverage items at each of the Games (estimated retail value of CAD \$400);
 - (v) the opportunity for the winner's Child (and up to one additional Prize Participant who is a child between the age of six (6) and fourteen (14) years of age) to participate in the on-field *Jr. Jays*TM starting lineup at one of the Games (specific game to be determined by RBJBP in its sole discretion) (the "**Starting Lineup Prize**") (estimated retail value of CAD \$400);
 - (vi) one (1) Nerf prize pack (estimated retail value of CAD \$500); and
 - (vii) subject to subsection 5(a) of these Official Rules, below:
 - (A) round trip economy air transportation for the Prize Participants from the international airport within Canada closest to the winner's residence (as determined in the sole discretion of Sponsor) to the Destination on travel dates to be determined by Sponsor (the "**Airfare**") (estimated retail value of CAD \$3400); and
 - (B) return ground transportation for the Prize Participants from the Destination airport to the Hotel (the "**Ground Transportation**") (estimated retail value of CAD \$400).

The total estimated retail value of the Grand Prize (inclusive of Airfare and Ground Transportation) is CAD \$9,500. Actual retail value of the Grand Prize will depend on whether the winner resides within 300 kilometres of the Stadium (in which case Airfare and Ground Transportation will not be provided, as more particularly set out in subsection 5(a) of these Official Rules, below) and, if the winner resides further than 300 kilometres of the Stadium, on the winner's departure city (the estimated retail value of the Airfare is based on the departure city of Ottawa, Ontario). Any difference in value will not be awarded.

(b) **Secondary Prizes:** Ten (10) eligible entrants will each win one (1) secondary prize (each, a “**Secondary Prize**”) each consisting of:

- (i) one (1) Nerf Elite JR Explorer;
- (ii) one (1) Nerf Elite JR Starter Set
- (iii) one (1) package of Nerf Elite 2.0 dart set (80 darts within one package);
- (iv) one (1) Nerf N-Series Ward;
- (v) one (1) Nerf N-Series refill pack (containing 80 pieces);
- (vi) one (1) Nerf N-Series Pinpoint;
- (vii) one (1) Nerf N-Series Agility;
- (viii) one (1) Nerf N-Series Gear-Up Pack;
- (ix) one (1) Nerf N-Series Shadow Storm;
- (x) one (1) Nerf N-Series Infinite; and
- (xi) one (1) Nerf Better Than Balloons package (228 pods in total).

The total estimated retail value of each Secondary Prize is CAD \$295. Any difference in value will not be awarded.

The ten (10) Secondary Prizes will be regionally allocated as follows:

- one (1) prize (the “**Atlantic Region Prize**”) will be awarded to a resident of any of Newfoundland and Labrador, New Brunswick, Prince Edward Island or Nova Scotia (such provinces, collectively, the “**Atlantic Region**”);
- one (1) prize (the “**Quebec Region Prize**”) will be awarded to a resident of Quebec;
- two (2) prizes (each, an “**Ontario Prize**”) will be awarded to residents of Ontario;
- one (1) prize (the “**Manitoba Prize**”) will be awarded to a resident of Manitoba;
- one (1) prize (the “**Saskatchewan Prize**”) will be awarded to a resident of Saskatchewan;
- one (1) prize (the “**Alberta Prize**”) will be awarded to a resident of Alberta;
- two (2) prizes (each, a “**British Columbia Prize**”) will be awarded to residents of British Columbia; and
- one (1) prize (the “**Northern Territories Region Prize**”) will be awarded to a resident of any of Northwest Territories, Yukon, or Nunavut (such province and territories, collectively, the “**Northern Territory Region**”).

The Grand Prize and the Secondary Prizes are hereafter collectively referred to as a the “Prizes”. There is a limit of one (1) Prize per person.

5. PRIZE CONDITIONS:

- (a) If the Grand Prize winner resides within 300 kilometres of the Stadium, Airfare and Ground Transportation will not be awarded and the Prize Participants will be solely responsible for all costs of transportation (and no additional compensation or substitution will be awarded for any difference in prize value).
- (b) Notwithstanding anything to the contrary herein, the Grand Prize winner and their Child must be available to attend the Games on the date selected by the Sponsor and RBJBP. Should a Grand Prize winner and/or their Child not be unable to attend the any of the Games, the Grand Prize will be forfeited in its entirety and may be awarded to an alternate Grand Prize winner in accordance with these Official Rules.
- (c) Any and all Contest prizes must be accepted as awarded and may not be transferred, resold, commercially traded, assigned, or redeemed for cash except at Sponsor’s and RBJBP’s sole and absolute discretion. Sponsor and RBJBP reserve the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at their sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, any prize is provided “as is” without further warranty of any kind.
- (d) All prize details, including Airfare and Ground Transportation times, if applicable, the location of the Hotel, the dates of the Games, the exact nature and type of any merchandise forming part of the prize and the Game seat locations, will be determined in the sole discretion of Sponsor and/or RBJBP. In particular, the Grand Prize winner and their Child must be present at the location and time communicated to them by RBJBP on the day of the applicable Game in order to receive and participate in the Starting Lineup Prize. If the Grand Prize winner and Child are not present in accordance with the instructions of RBJBP, the Grand Prize winner will forego the opportunity for their Child to participate in the Starting Lineup Prize. For certainty, if the additional Prize Participant selected by the Grand Prize winner to participate in the Starting Lineup Prize is a child between the age of six (6) and fourteen (14) years of age, the Grand Prize winner and/or the fourth Prize Participant must be the parent/legal guardian of such child.
- (e) If the Grand Prize winner is entitled to Airfare and Ground Transportation, travel arrangements must be made through Sponsor’s agent on a carrier of Sponsor’s choice and tickets will be subject to those terms and conditions specified by the ticket issuers. In addition, if the Grand Prize Winner is entitled to Airfare and Ground Transportation, the Prize Participants must travel together on the same itinerary and are responsible for ensuring they have all necessary travel documents (e.g., valid passport and, if required, valid proof of vaccination and/or negative COVID-19 test results). RBJBP, Sponsor and the MLB Entities are not responsible in the event any Prize Participant is refused boarding at any time by any airline or airport security. Any unused portion of the prize will be forfeited. Each Prize Participant must be of age of legal majority in his/her jurisdiction of residence, unless accompanied by a parent or legal guardian.
- (f) The winners of any Prize are fully responsible for any and all applicable federal, provincial, and municipal taxes (including income and withholding taxes).
- (g) Use of any Major League Baseball game/event/exhibition ticket is subject to standard terms, conditions, and health and safety policies applicable to the ticket; see bluejays.com/ticketterms for

details. Major League Baseball game, event and exhibition dates and times are determined in the sole discretion of the BOC and/or the applicable Club, as applicable, and may be subject to change. The terms and conditions of the tickets awarded as part of the/each prize will govern in the event a legal game, event or exhibition, as defined by Major League Baseball, is not played or held, as applicable, due to weather conditions, an act of God, an act of terrorism, civil disturbance or any other reason. The Grand Prize winner and his/her/their guests agree to comply with all applicable stadium and venue, as applicable, regulations in connection with the prize; see bluejays.com/ticketterms for details. The applicable MLB Entities reserve the right to remove or to deny entry to any winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game, event or exhibition. The Released Parties (defined below) will not be responsible for acts of God, acts of terrorism, civil disturbances, work stoppages, epidemic, pandemic, or any other issue concerning public health or safety, or any other event outside of their control that may cause the cancellation or postponement of any Major League Baseball game, event or exhibition. Major League Baseball game, event and exhibition tickets awarded as part of the Grand Prize may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the licence granted by the game, event or exhibition tickets.

- (h) Any and all additional costs and expenses associated with prize acceptance and use not specified herein as being provided including but not limited to travel and health insurance, transportation costs (including: checked baggage fees, excess baggage fees, meals, gratuities and other expenses incurred by the winners (and any guests) in claiming, accepting and/or using the prize are the sole responsibility of each individual winner.
- (i) Participation in the Starting Lineup Experience is subject to Grand Prize winner and their Child's consent to and compliance with all health and safety policies of the MLB Entities.

6. RANDOM DRAW:

- (a) **Grand Prize Draw:** At approximately 10:00 a.m. ET on Friday, July 19, 2024 at the office of RBJBP located at One Blue Jays Way, Suite 3200, Toronto, Ontario M5V 1J1, a RBJBP representative, or other person designated by RBJBP will select by random draw one (1) potential Grand Prize winner from among all eligible Entries received during the Entry Period.

Odds of winning the Grand Prize depend on the number of eligible Entries received during the Entry Period.

- (b) **Secondary Prize Draws.** At approximately 10:00 a.m. ET on Friday, July 19, 2024 at the office of RBJBP located at One Blue Jays Way, Suite 3200, Toronto, Ontario M5V 1J1, a RBJBP representative, or other person designated by RBJBP will conduct a series of random draws to determine one (1) potential Atlantic Region Prize winner, one (1) potential Quebec Region Prize winner, two (2) potential Ontario Prize winners, one (1) potential Manitoba Prize winner, one (1) potential Saskatchewan Prize winner, one (1) potential Alberta Prize winner, two (2) potential British Columbia Prize winners, and one (1) potential Northern Territories Region Prize winner, as follows:
 - (i) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of the Atlantic Region, such entrant to be deemed the potential Atlantic Region Prize winner. The odds of being selected as the potential Atlantic Region Prize winner depend on the total number of eligible Entries received from residents of the Atlantic Region;

- (ii) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of Quebec, such entrant to be deemed the potential Quebec Prize winner. The odds of being selected as the potential Quebec Prize winner depend on the total number of eligible Entries received from residents of Quebec;
- (iii) two (2) eligible entrants will be selected by random draw from among all eligible Entries received from residents of Ontario, such entrants to be deemed the potential Ontario Prize winners. The odds of being selected as the potential Ontario Prize winner depend on the total number of eligible Entries received from residents of Ontario;
- (iv) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of Manitoba, such entrant to be deemed the potential Manitoba Prize winner. The odds of being selected as the potential Manitoba Prize winner depend on the total number of eligible Entries received from residents of Manitoba;
- (v) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of Saskatchewan, such entrant to be deemed the potential Saskatchewan Prize winner. The odds of being selected as the potential Saskatchewan Prize winner depend on the total number of eligible Entries received from residents of Saskatchewan;
- (vi) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of Alberta, such entrant to be deemed the potential Alberta Prize winner. The odds of being selected as the potential Alberta Prize winner depend on the total number of eligible Entries received from residents of Alberta; and
- (vii) one (1) eligible entrant will be selected by random draw from among all eligible Entries received from residents of the Northern Territories Region, such entrant to be deemed the potential Northern Territories Region Prize winner. The odds of being selected as the potential Northern Territories Region Prize winner depend on the total number of eligible Entries received from residents of the Northern Territories Region.

Odds of winning a Secondary Prize depend on the number of eligible Entries received during the Entry Period.

Limit of one (1) Prize per person/Child during the Entry Period.

7. **NOTIFICATION:** Each potential winner selected in accordance with the previous section will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her/their Entry to determine if he/she/they is/are eligible in the sole discretion of the RBJBP representative. In the event that any potential winner does not respond to such notification within two (2) days, incorrectly answers the skill testing question (described in more detail below), as determined by Sponsor or RBJBP in its sole discretion or declines a prize for any reason, he/she/they will be disqualified, the prize will be forfeited and, at Sponsor's discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries.

8. DECLARING A WINNER:

- (a) To be declared a winner and claim the prize awarded, a potential winner must (i) be eligible according to these Official Rules, (ii) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time limited mathematical skill testing question which will be administered by telephone at a mutually agreeable time, and (iii) sign a duly completed Liability and, except where prohibited by law, Publicity Release form, on behalf of him/herself/themself

and, for the Grand Prize, on behalf of his/her/their Child, and any other documentation as may reasonably be required by RBJBP, and return same to Sponsor (or if directed, RBJBP) by the date specified on the applicable documentation.

- (b) If all required documents are not properly executed and returned within the specified period of time, or the potential winner otherwise fails to comply with these Official Rules, a disqualification will result and the prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible Entries. The Grand Prize winner's guests must also sign a duly completed Liability and, except where prohibited by law, Publicity Release form and return same to Sponsor (or, if directed, RBJBP) by the date specified in order to participate in the prize.

9. WAIVER OF LIABILITY/PUBLICITY RELEASE:

- (a) By participating in the Contest and submitting an Entry, each entrant (i) agrees to be bound by these Official Rules, including all Entry requirements, (ii) agrees that the decisions of Sponsor and RBJBP are final and without appeal, (iii) remises, releases and forever discharges Sponsor, RBJBP, the other MLB Entities, all provincial liquor boards and/or agencies, all liquor sales licensees, Facebook, Inc. ("**Facebook**"), Instagram, Inc. ("**Instagram**"), Twitter, Inc. ("**Twitter**"), each of their respective parents, affiliated companies and subsidiaries, any and all other companies associated with the Contest (including prize suppliers and suppliers of materials or services related to the Contest), and all of their respective employees, directors, officers, shareholders, agents, representatives, successors and assigns (collectively, the "**Released Parties**") from any and all actions, causes of actions, suits, debts, dues, accounts, claims, damages, liability, losses, harm, costs or expenses, including without limitation any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, arising out of, or in any way related to, directly or indirectly, the Contest, including without limitation the entrant's participation in the Contest, any breach of these Official Rules, the awarding, receipt, possession, use and/or misuse of any Contest prize (or any portion thereof), and any travel or activity that is related to the receipt or use of any Contest prize, and/or the violation or infringement of any intellectual property rights or of any publicity, personality or privacy rights, and agrees to fully indemnify the Released Parties, Instagram, Twitter, and Facebook from any and all claims by third parties relating to the foregoing.
- (b) By accepting a prize, each winner authorizes Sponsor, RBJBP, MLBAM, the other MLB Entities and each of their respective designees to use in any related publicity, such winner's name, city and province/territory of residence, photograph, image, likeness, voice, and any statements he/she may make regarding such prize for advertising and promotional purposes worldwide in perpetuity and in any form of media now or hereafter devised worldwide (including the Internet), without limitation and without additional compensation or consideration, notification or permission, unless prohibited by law; and waives any rights that may exist in respect of materials produced pursuant to the foregoing.

10. GENERAL CONTEST TERMS AND CONDITIONS:

- (a) The Released Parties are not responsible for (i) stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due or garbled entries, transmissions, email or mail; (ii) lost, interrupted or unavailable network, cable, satellite, server, Internet Service Provider, website, or other connections including those through and/or by any website; (iii) availability or accessibility or miscommunications or failed computer, satellite, telephone, cable transmissions, lines, or technical failure or jumbled, scrambled, delayed,

or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (iv) failures or malfunctions of phones, phone lines or telephone systems, (v) any error, omission, interruption, defect or delay in transmission, processing, or communication; (vi) non-delivery of any communication or Entry; (vii) misdirected, blocked, or delayed email notifications; (viii) printing, typographical or other errors appearing within these Official Rules, in any Contest-related advertisements or other materials; (ix) any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network, computer, telephone, mail, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of Entries, the announcement of any prize in any Contest-related materials, or the cancellation or postponement of any Major League Baseball game, event or exhibition, (x) any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest; or (xi) any injury or damage to the computer of any entrant or other person related to or resulting from participating in this Contest or downloading materials from or use of any website.
