

2024 JR. JAYS™ CLUB GAME ON CONTEST (the “Contest”)

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. CONTEST OPERATOR: The operator of this Contest is Rogers Blue Jays Baseball Partnership, located at One Blue Jays Way, Suite 3200, Toronto, Ontario M5V 1J1 (“**RBJBP**”).

2. ELIGIBILITY:

- (a) To be eligible to enter the Contest, you must: (i) be a legal resident of Canada, excluding the province of Quebec; (ii) be of legal age of majority in the province/territory in which you reside (and at least eighteen (18)); and (iii) be the parent or legal guardian of a child (A) aged fourteen (14) or under (the “**Child**”) as of April 3, 2024; and (B) who is a member of the *Jr. Jays* Club.
- (b) The following individuals and their household members (whether or not related) are not eligible to enter the Contest: employees, officers, directors, shareholders, agents, representatives, successors and assigns of each of (i) RBJBP, owner of the *Toronto Blue Jays*™ Major League Baseball team (the “**Team**”) (ii) the other MLB Entities (defined below), (iii) each of their respective parents, affiliated companies, and subsidiaries, and (iv) any and all other companies associated with the Contest. The “**MLB Entities**” shall mean the Office of the Commissioner of Baseball (the “**BOC**”), its Bureaus, Committees, Subcommittees and Councils, MLB Advanced Media, L.P. (“**MLBAM**”), Major League Baseball Properties, Inc., The MLB Network, LLC, the Major League Baseball Clubs (the “**Clubs**”), each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.
- (c) RBJBP shall have the right at any time to require proof of identity and/or eligibility to enter the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. RBJBP reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

3. HOW TO ENTER:

- (a) The Contest entry period (the “**Entry Period**”) begins at 10:01 a.m. Eastern Time (“**ET**”) on April 3, 2024, and ends at 9:59 a.m. ET on October 1, 2024, and will consist of multiple Draw Dates (as defined below).
- (b) There is one (1) way to enter: via the 2024 *Jr. Jays* Club online portal. No other method of entry will be accepted. During the Entry Period, you may enter the Contest by logging into the *Jr. Jays* portal online at <https://myportal.bluejays.com> and participate in one interactive game or complete one interactive worksheet (each, an “**Activity**”). By completing an Activity, you will receive one (1) entry into the Contest (each, an “**Entry**”).

Limit of one (1) Entry per person, per Child of an entrant. **For certainty, Entries (as defined above) from one Entry Period will not carry over to subsequent Entry Periods.**

- (c) MLBAM’s computer shall be the official clock of the Contest with respect to entries submitted online. Free access to the Internet is available at most public libraries. Entrants are solely responsible for Internet connectivity, software and/or hardware that may be required in order to enter the Contest.

(d) All information submitted via email and the *Jr. Jays* Club online portal or offline is being collected by RBJBP. By entering this Contest, each entrant consents to the collection, use, and disclosure of his/her personal information, and that of the Child, for the purposes and in the manner described herein. All personal information submitted by entrants on the *Jr. Jays* Club All-Star online portal is subject to the *Jr. Jays* Club All-Star privacy policy, which is displayed on such online activation form.

4. **PRIZE DESCRIPTION:** Thirty (30) eligible entrants will each win one (1) autographed baseball, with an approximate retail value is CAD \$100.00.

5. **PRIZE CONDITIONS:**

(a) Actual value of each autographed item is subject to market fluctuations. No certificate of authenticity is provided by Sponsor. Item is not used.

(b) Any and all Contest prizes must be accepted as awarded and may not be transferred, resold, commercially traded, assigned, or redeemed for cash except at RBJBP's sole and absolute discretion. RBJBP reserves the right to substitute any stated prize (or portion thereof) with an alternate prize of comparable or greater value at its sole and absolute discretion, for whatever the reason. Prizes may not be exactly as advertised, and except as expressly warranted herein, any prize is provided "as is" without further warranty of any kind.

(c) All prize details, including the quality and type of any merchandise awarded will be determined in the sole discretion of RBJBP.

(d) Any and all additional costs and expenses associated with prize acceptance and use not specified herein as being provided including but not limited to transportation costs and other expenses incurred by each winner and his/her Child in claiming, accepting and/or using the prize are the sole responsibility of such winner.

6. **RANDOM DRAW:** At approximately 10:00 a.m. ET on each of the draw dates set forth in the Draw Schedule below (each, a "**Draw Date**"), a RBJBP representative will select by random draw the applicable number of potential winners from among all eligible entries received during the applicable Entry Period and will decide, in its sole discretion, which prize from among the applicable prizes for that Entry Period will be awarded to each potential winner should he/she be declared a winner. For certainty, unselected Entries from one Entry Period will carry over to each subsequent Entry Period (if any). Limit of one (1) prize per winner/Child. Odds of winning depend on the number of eligible entries during the applicable Entry Period.

7. **NOTIFICATION:** Each potential winner selected in accordance with the previous section will be contacted by a RBJBP representative by telephone at the telephone number indicated in his/her activation card, online activation form or email, as applicable, to determine if he/she is eligible in the sole discretion of the RBJBP representative. In the event that any potential winner does not respond to such notification within three (3) business days, incorrectly answers the skill testing question (described in more detail below), as determined by RBJBP in its sole discretion or declines a prize for any reason, he/she will be disqualified, the prize will be forfeited and, at RBJBP's discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries received during the applicable Entry Period.

8. **DECLARING A WINNER:**

All disputes will be resolved in the Province of Ontario under applicable Ontario and Federal laws.
- (c) RBJBP and MLBAM reserve the right, in their sole discretion, to cancel, suspend or otherwise modify the Contest (or any portion thereof) and/or to amend these Official Rules at any time and in any way, without prior notice, for any reason, including, but not limited to incidents where a virus, bug, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Contest (or any portion thereof). In the event of cancellation, RBJBP may elect to identify winners and award the prizes by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation.
