

# **LOS ANGELES DODGERS – 2023 SEASON TICKET HOLDERS**

## **POSTSEASON TERMS AND CONDITIONS**

### **1. Postseason Invoice:**

Your 2023 postseason invoice includes billing for tickets for up to fourteen (14) possible 2023 Playoff Games at Dodger Stadium: three (3) Wild Card games, three (3) Division Series games, four (4) League Championship Series games, and four (4) World Series games. The number of tickets for each Playoff Game and the selection of possible Playoff Games to be provided will be based on the specific season ticket membership that you purchased pursuant to the 2023 Ticket Purchase Agreement entered into by and between you and Dodger Tickets LLC (the “**2023 Ticket Purchase Agreement**”). If you purchased 2023 preferred season parking, your 2023 postseason invoice will also include billing for preferred parking passes to the possible Playoff Games. Tickets and parking passes will be designated Wild Card Home Game 1, 2, 3; Division Series Home Game 1, 2, 3; League Championship Series Home Game 1, 2, 3, 4; and World Series Home Game 1, 2, 3, 4.

### **2. Due Date:**

Payment of your 2023 postseason invoice must be received in full on or before **September 14, 2023** (the “**Due Date**”). In the event that full payment is not received by the Due Date, the offer to purchase tickets and/or parking passes to the 2023 Playoff Games shall be revoked with no further reminders and/or communications from Dodger Tickets LLC and/or Los Angeles Dodgers LLC (hereinafter individually and collectively referred to as the “**Dodgers**”). The Dodgers are not responsible for delays or payments lost by any delivery service. Please be advised that the payment deadline will be strictly enforced.

### **3. Payment Options:**

Beginning immediately, you may pay your 2023 postseason invoice online by logging into your “My Dodgers Tickets” account at [www.dodgers.com/mytickets](http://www.dodgers.com/mytickets), and then clicking on “RENEW/MAKE PAYMENTS” on the homepage. Payment of your 2023 postseason invoice must be received in full by the Due Date.

### **4. Ticket Delivery:**

In September, all purchased tickets and parking passes for Playoff Games will be delivered electronically to your “My Dodgers Tickets” account. You will be notified via email when they are available. You have the ability to forward, print, and download the tickets and/or parking passes to your mobile device.

### **5. Ticket Refund/Account Credit for Unplayed Playoff Games:**

If the maximum number of Playoff Games at Dodger Stadium are not played in a postseason series, the amount paid for such unplayed Playoff Games, including the per ticket facility fee and parking (if applicable), will automatically be credited to your “My Dodgers Tickets” account. Such a credit balance does not create any rights to obtain any game tickets and/or parking passes for any future season. If you do not want a credit applied to your “My Dodgers Tickets” account for any unplayed Playoff Games, please contact your ticket representative or email the Dodgers’ Ticket Office directly at [mvp@ladodgers.com](mailto:mvp@ladodgers.com) for a refund. **Refunds will only be issued to the season ticket holder of record and in the same method that the payment was made. Please allow 4-6 weeks after the final Dodgers’ Playoff Game has been played for refund processing.**

### **6. Rainouts/Postponements:**

If any Playoff Game is officially rained out or postponed, an announcement regarding the rescheduled date, time, and any other particulars will be made on KLAC 570 AM and the Dodgers’ website at [www.dodgers.com](http://www.dodgers.com). In the event of a rainout or postponement, please retain your ticket. Replacement tickets will not be issued.

### **7. Communication via E-mail:**

To continue to provide you with up-to-the-minute information regarding your account, game time changes, promotions, media releases, and ticket specials, we ask that you provide an email address for the contact person assigned to your “My Dodgers Tickets” account.
