I agree that the Cincinnati Reds, the Cincinnati Reds Community Fund, the MLB Entities and certain current and future sponsors and licensees of such MLB Entities will have the unrestricted right and license to use my image, likeness, name, voice, comments and/or other proprietary or public rights and/or my Child in any live or recorded broadcast, telecast, photograph, video, audio, audiovisual and/or other recording taken in connection with the Activities or other transmission, distribution, public performance, or reproduction in whole or in part of the Activities, for all purposes, worldwide, in perpetuity, and in any and all media now or hereafter known, without compensation.

THE RELEASED PARTIES, MY CHILD AND I SHALL NOT BE ENTITLED TO JOIN OR CONSOLIDATE CLAIMS IN ARBITRATION BY OR AGAINST OTHER INDIVIDUALS OR ENTITIES, OR ARBITRATE AS A REPRESENTATIVE MEMBER OF A PUTATIVE CLASS OR IN A PRIVATE ATTORNEY GENERAL CAPACITY. THE ARBITRATOR SHALL HAVE THE POWER TO AWARD ANY REMEDIES AVAILABLE UNDER APPLICABLE LAW. ANY AWARD AND ANY JUDGMENT CONFIRMING IT ONLY APPLIES TO THE ARBITRATION IN WHICH IT WAS AWARDED AND CANNOT BE USED IN ANY OTHER CASE EXCEPT TO ENFORCE THE AWARD ITSELF.
