



Royals Yoga Participation General Release and Indemnification - ADULT

The undersigned (the "Participant") hereby executes and delivers this General Release and Indemnification (the "Release") to the Kansas City Royals Baseball Club, LLC (the "Royals"), the assigns, predecessors, successors, officers, directors, agents, representatives, employees, subsidiaries, sub-contractors, shareholders, and affiliates of the Royals, all Major League Baseball entities, affiliates and member baseball clubs, Jackson County Missouri and the Jackson County Sports Complex Authority (collectively, the "Releasees") (together, the "Released Parties").

Participant (1) desires to participate in the Royals Yoga Event (the "Program"), including any elements of yoga, baseball games, races, contests and other activities scheduled to take place on June 2, 2024 at Kauffman Stadium in Kansas City; (2) acknowledge and understand that they will be engaging in athletic events and activities in the Program that involve the risk of serious injury, property damage and even death, any of which might result not only from their own actions or negligence, but the actions or negligence of others, the rules of play, the condition of the premises or any equipment, or other risks not known or reasonably foreseeable at this time; and (3) understand that execution of this Release is a condition to their participating in the Program.

NOW, THEREFORE, in consideration of the premises, including the Participant's participation in the Program:

1. The undersigned, on behalf of himself/herself and their family, estate, heirs, executors, administrators and assigns, hereby releases all Released Parties from any and all claims, liability, obligation, loss and causes of action for personal injury, property damage, or other loss of any kind, whether known or unknown, suspected or unsuspected, asserted or not asserted, arising out of their participation in the Program and caused by the negligence of any person, including one or more of the Released Parties. This Release does not release the Released Parties from liability for injuries or loss resulting from their gross negligence or intentional misconduct.
2. The undersigned, on behalf of himself/herself and their family, estate, heirs, executors, administrators and assigns, hereby agrees to indemnify and hold harmless the Released Parties from any loss, liability, injury, damage or costs including reasonable attorneys' fees, that coach or trainer or any Released Party may incur directly or indirectly due to their participation in the Program, whether caused by their own negligence or the negligence of another person, including one or more of the Released Parties.
3. The undersigned, on behalf of himself/herself and their family, estate, heirs, executors, administrators and assigns, hereby represent that they (a) are in good health and physically able to participate in the Program and (b) covered by sufficient health insurance to cover costs and expenses (should they arise) from participation in the Program.

4. The undersigned, on behalf of himself/herself and their family, estate, heirs, executors, administrators and assigns, hereby grants the perpetual, worldwide right to make both visual and/or audio recordings and still images of me and to use my name, voice, likeness, and biographical information in connection with any of the Royals games, Royals related programming, promotional/marketing materials, and/or other media (collectively, the "Media") and for the purpose of advertising, marketing and/or promoting the Released Parties and their sponsors. I agree that the rights granted hereunder shall include the perpetual, worldwide right of the Released Parties and their sponsors to edit, telecast, cablecast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit the Media in any manner and in any medium or forum whether now known or hereafter devised, in whole or in part, without any further compensation. I hereby release and discharge the Royals and all Major League Baseball entities, affiliates and member baseball clubs from any and all claims and demands arising out of or in connection with the use of the image, likeness and name of myself, including any claim for libel, commercial appropriation, or invasion of right of privacy or publicity.
5. This Release shall be governed by the laws of the State of Missouri. The undersigned agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
6. COVID-19 is an extremely contagious disease that can lead to severe illness and death. An inherent risk of exposure to COVID-19 exists in any public place regardless of precautions that may be taken. Participant agrees to a) assume all risks associated with COVID-19 and any other Communicable Diseases and b) comply with any prescribed and/or posted safety policies/protocols of the Kansas City Royals Baseball Club, LLC and applicable state and local authorities. Participant acknowledges that, if infected with COVID-19 or other Communicable Disease (as defined at the conclusion of this paragraph), they and/or any others present for the Program may infect others even if they are not experiencing or displaying any symptoms of illness, and that the risk of exposure to others remains at all times. Accordingly, undersigned agrees not to attend the Events if within 10 days preceding the date of the Event/Activity they have:
 - Tested positive or presumptively positive for COVID-19 or other Communicable Disease or been identified as a potential carrier of COVID-19 or other Communicable Disease
 - Experienced any symptoms commonly associated with COVID-19 or other Communicable Disease.
 - Been in direct contact with or in the immediate vicinity of any person who is confirmed or suspected of being infected with COVID-19 or other Communicable Disease
 - A "Communicable Disease" as used herein is COVID-19, any strains, variants, or mutations thereof, the coronavirus that causes COVID-19, and/or any other communicable and/or infectious diseases, viruses, bacteria or illnesses or the causes thereof.

7. This Release is governed by the laws of the State of Missouri. The undersigned agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that if any portion hereof is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect. This Release may not be modified orally and a waiver of any provision will not be construed as a modification or waiver of any other provision herein or as consent to any subsequent waiver or modification. Participant's signature sent by facsimile or submitted via electronic transmission will be deemed to constitute an original and fully effective signature of Participant.

8. The undersigned represents that he or she has read this Release, fully understand its contents, and hereby execute it on behalf of himself/herself.
