



Royals Yoga Participation General Release and Indemnification - YOUTH

As the parent or legal guardian of _____ ("Participant"), the undersigned, on behalf of the undersigned and Participant, hereby executes and delivers this General Release and Indemnification (the "Release") to the Kansas City Royals Baseball Club, LLC (the "Royals"), the assigns, predecessors, successors, officers, directors, agents, representatives, employees, subsidiaries, subcontractors, shareholders, and affiliates of the Royals, all Major League Baseball entities, affiliates and member baseball clubs, Jackson County Missouri and the Jackson County Sports Complex Authority (collectively, the "Releasees") (together, the "Released Parties").

Participant and the undersigned (1) desire that Participant participate in the Royals Yoga Event (the "Program"), including any elements of yoga, baseball games, races, contests and other activities scheduled to take place on June 2, 2024 at Kauffman Stadium in Kansas City; (2) acknowledge and understand that Participant will be engaging in athletic events and activities in the Program that involve the risk of serious injury, property damage and even death, any of which might result not only from Participant's own actions or negligence, but the actions or negligence of others, the rules of play, the condition of the premises or any equipment, or other risks not known or reasonably foreseeable at this time; and (3) understand that execution of this Release is a condition to Participant's participating in the Program.

NOW, THEREFORE, in consideration of Participant's participation in the Program:

1. The undersigned, on behalf of himself/herself, Participant and Participant's family, estate, heirs, executors, administrators and assigns, hereby releases all Released Parties from any and all claims, liability, obligation, loss and causes of action for personal injury, property damage, or other loss of any kind, whether known or unknown, suspected or unsuspected, asserted or not asserted, arising out of Participant's participation in the Program. This Release does not release the Released Parties from liability for injuries or loss resulting from their gross negligence or intentional misconduct.
2. The undersigned, on behalf of himself/herself, Participant and Participant's family, estate, heirs, executors, administrators and assigns, hereby agrees to indemnify and hold harmless the Released Parties from any loss, liability, injury, damage or costs including reasonable attorneys' fees, that Participant or any Released Party may incur directly or indirectly due to Participant's participation in the Program, whether caused by the negligence of Participant or another person, including one or more of the Released Parties.
3. The undersigned, on behalf of himself/herself, Participant and Participant's family, estate, heirs, executors, administrators and assigns, hereby represents that (a) Participant is in good health and is physically able to participate in the Program and (b) Participant is covered by sufficient health insurance to cover costs and expenses of injuries (should they arise) from Participant's participation in the Program.

4. The undersigned, on behalf of himself/herself, Participant and Participant's family, estate, heirs, executors, administrators and assigns, hereby grants the right to make both visual and/or audio recordings and still and digital images of Participant and to use Participant's name, voice, likeness, and biographical information in connection with any Royals games, Royals-related programming, promotional/marketing materials, and/or other media (collectively, the "Media") and for the purpose of advertising, marketing and/or promoting any or all of the Released Parties and/or their sponsors. The rights granted hereunder include the perpetual, worldwide right of the Released Parties and their sponsors to edit, telecast, cablecast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit the Media in any manner and in any medium or forum whether now known or hereafter devised, in whole or in part, without any further compensation.
5. This Release is governed by the laws of the State of Missouri. The undersigned agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that if any portion hereof is held invalid, it is agreed that the balance will continue in full legal force and effect.
6. COVID-19 is an extremely contagious disease that can lead to severe illness and death. An inherent risk of exposure to COVID-19 exists in any public place regardless of precautions that may be taken. The undersigned, on behalf of himself/herself and Participant agrees to a) assume all risks associated with COVID-19 and any other Communicable Diseases and b) comply with any prescribed and/or posted safety policies/protocols of the Kansas City Royals Baseball Club, LLC and applicable state and local authorities. The undersigned acknowledges that, if infected with COVID-19 or other Communicable Disease (as defined at the conclusion of this paragraph), they and/or Participant as well as any others present for the Program may infect others even if they are not experiencing or displaying any symptoms of illness, and that the risk of exposure to others remains at all times. Accordingly, undersigned agrees they and Participant will not attend the Events if within 10 days preceding the date of the Event/Activity they have:
 - Tested positive or presumptively positive for COVID-19 or other Communicable Disease or been identified as a potential carrier of COVID-19 or other Communicable Disease
 - Experienced any symptoms commonly associated with COVID-19 or other Communicable Disease.
 - Been in direct contact with or in the immediate vicinity of any person who is confirmed or suspected of being infected with COVID-19 or other Communicable Disease
 - A "Communicable Disease" as used herein is COVID-19, any strains, variants, or mutations thereof, the coronavirus that causes COVID-19, and/or any other communicable and/or infectious diseases, viruses, bacteria or illnesses or the causes thereof.

7. The undersigned represents (a) that he or she is the father, mother or legal guardian of the above-named Participant, who is under the age of eighteen, and (b) that he or she has read this Release, fully understood its contents, and hereby executes it on behalf of himself/herself and Participant.
